1. The tenant and/or registered owner must be notified by written notice delivered in a) person, b) by e-mail, or c) by first-class mail with a certificate of mailing (if notification is by certified letter, 2 letters must be sent - one returned letter or signed card will be kept by facility and one will be given to buyer). **Notification MUST include complete information - Year, Make, Model, VIN #, Storage Facility information, Tenant Name and/or Registered Owner, and Unit #. Notification must be sent at least 32 days in advance of the auction. (The sent date and the auction date cannot be counted.)**

2. Provide a copy of notification for buyer (to take to DMV office) and keep one on file at Storage Facility.

3. Advertise in local newspaper with **tenant and/or owner name, Yr, Make, Model, VIN #, Storage Facility Information, and Unit #.**
